Jeffrey Gray's BIS is a neuropsychological system that predicts an individual's response to anxiety-relevant cues, contrasting with the reward-seeking BAS.

6. How does the 'Lexical Hypothesis' serve as the foundational logic for the development of modern Factor Analytic models of personality?

Answer: B) It suggests that significant individual differences are encoded into natural language over time.

The Lexical Hypothesis asserts that important personality characteristics will eventually become part of a culture's language, allowing researchers to use dictionaries to identify key traits.

Research suggests that Locus of Control can be multi-dimensional and domain-specific; for example, one might have an internal locus for academics but an external locus for health.

Alfred Adler argued that the primary motivator of personality is the move from a sense of inferiority toward mastery or perfection, which he termed 'striving for superiority'.
